FEEES FOR 2012 SEASON (Starts: Monday 16th April – Ends 28TH SEPTEMBER)

In order to achieve transparency and fairness regarding the fees paid by ALL platform users during the summer season, the Committee has decided to introduce a tariff system based on the actual square meters occupied by boats as well as their launching procedures.

Below are the four types defined and the associated fee per square meter. A table covering the most common types of boats is also provided. Should your boat not be listed, please provide an objective measurement of your LOA and WOA including trailer and / or launching trolley.

The Boathouse Captain reserves the rights to review the measurements provided and to adjust the parking fee accordingly. HIS DECISION WILL BE FINAL.

Type 1: Dinghies	Fee per sqm: €22.00
Type 2: Boats using the winch	Fee per sqm: €30.00
Type 3 Boats using the crane(s) but not the forklift	Fee per sqm: €60.60
Type 4: Boats using the crane(s) and the forklift	Fee per sqm: €88.00

Your application will be checked and only fully completed forms will be accepted.

- Incomplete forms will be returned to the owner, to be completed in full and returned to the club office, before parking is granted.
- **You will be issued with your parking sticker and details as to when you may bring your boat onto the platform.**
- **Boats may not enter on to the platform till they have their parking sticker displayed.**
- **Boats found on the platform, without a current parking sticker, will be impounded.**
- All road trailers must be removed from the platform and are not permitted to remain on launching trolleys.
- In the event of platform congestion, boats that are not sailed frequently will be asked to vacate the platform and the appropriate refund returned.
- As space on the platform is at a premium the club will accept no new applications for Rib parking.
- Space for Dry Sailing, as for Ribs is limited and will be allocated on a first come first served basis, to boats with a single point lift, and within the 3200kg capacity of the Demag crane.

Terms & Conditions

1. I/We agree that my/our use of Platform, Crane, Forklift towing, Winch, Slipway. Membership facilities and Storage Space shall be at my/our own risk and that no liability whatsoever shall attach to the Club, its servants or agents in respect of any loss or damage arising from my/our own use of same.
2. I/We agree that I/We bear the responsibility to secure my/our boat on the platform during times of severe weather conditions.
3. I/We confirm that cradles, trailers, ladders and other equipment will be clearly marked with Boat's name, and will be in good mechanical working order, repair and condition.
4. I/We accept that unsuitable boats, cradles, trailers and equipment may not be accepted; Boathouse Captain and Platform Manager's decision is final.
5. I/We confirm that I/we hold adequate insurance against loss, damage or injury to persons and/or property.
6. I/We confirm that the vessel is my/our property and accept that whilst availing of the Club facilities, I/we shall be responsible for the management and control of the vessel and the conduct of its crew.
7. I/We have read and understand the "Platform Guidelines" (available on www.nyc.ie).
8. I/We understand that a current platform sticker must be affixed to my boat &/or trailer before entry to the platform.
9. I/We agree that I/we will remove the boat from the platform by or on the 28th September.
10. I/We accept that if the boat is still on the platform after the 28th September I/we will be invoiced with a **€100** fine, and should I/we fail to remove the boat seven days prior to the date set for lift out the Club may take possession of the boat and dispose of it.
11. **Additional space may be required for special events. I/we agree to remove the boat if requested in such circumstances.**
12. I/We agree that I/we will fully de-rig the boat after each use and stow it in a neat and orderly fashion
13. I/We understand that the boat may be stored on a rack if not used regularly (Lasers & Optimists)

Declaration

1. I/We hereby indemnify the Club, its members and its staff against any claim arising from the lifting, storing, moving, launching or parking of the above boat or its equipment.
2. I/We accept that the above conditions and indemnity apply to any and every lift, movement, launching, storing and parking of the above boat during the period set out above.
