**ALL CRADLES AND TRAILERS MUST BE REMOVED FROM THE PLATFORM BY  
FRIDAY 14th APRIL 2017  
A DAILY CHARGE OF €15 WILL APPLY TO ALL CRADLES THEREAFTER.**

Members requiring moorings for the coming season should complete the Application Form and return it to the office with the appropriate fee by **1st April, 2017**

Moorings will be allocated prior to lift-in, which is scheduled for **Saturday 8<sup>th</sup> April, 2017**  
Unsuccessful applicants will have their fee refunded at that time.

**Applications will only be considered where the form is fully completed and accompanied by the appropriate fee, **together with any outstanding account being cleared!****

The Boathouse Committee reserves the right to make such allocations, as they deem appropriate, as demand may exceed supply. Applicants who plan to be away with their boat for a number of weeks **are requested to advise** by enclosing a note with the application. This will make it possible for the Club to facilitate those members whom we might not be able to allocate a mooring.

**Charges for 2017 are split between mooring and launch ferrying charges. Launch charges apply to everybody using the service, including private mooring holders.**

## 2016 PONTOON BERTHING POLICY

Please note that, due to policies enforced by the Dun Laoghaire Harbour Co., mooring along the pontoon is not allowed except in exceptional cases and the Boathouse Captain reserves the right to charge for all such exceptions.

We would very much appreciate your zealous collaboration on this matter as Olivier and the boathouse staff will strictly enforce the "*Guidelines for Use of Platform & Pontoons*" listed on the following page.

**A fee of €40.00 will occur in the event of the boat needing to be brought back to its mooring or marina berthing by the Boathouse Staff.**

The following list aims to cover all cases where mooring along the breakwater will be allowed:

1. Boats on moorings who want an early departure before normal launch service begins.
2. Boats on moorings who arrive back after normal launch service ends.
3. Boats on moorings or marina that are loading supplies or equipment.
4. Boats on moorings or marina that are carrying out repairs that require the facilities of the pontoon.
5. Boats on moorings who are temporarily unseaworthy and cannot be left on the moorings.
6. Boats that are being used as Committee Boats for events.
7. Visiting boats that are HYC Associate or overseas members of the Club.
8. Special visitors who have been invited by the Club or who are taking part in races run by the Club e.g. ISORA boats, Cruising Company etc.
9. Boats on moorings or marina that due to "circumstances" (primarily weather) are unable to return the boats to their mooring.
